Colophon

The Lillian C. Liburdi Borrone Collection was processed by archivist Jannette L. D'Esposito during an internship for college credit in pursuit of a master's degree in Library and Information Science from St. John's University. Ms. D'Esposito was supervised during this project by Ms. Elizabeth Berilla, Reference, Instruction, and Outreach Librarian and Institutional Archivist at the Stephen B. Luce Library and Archives. Previously Ms. D'Esposito interned at the American Museum of Natural History's Research Library processing and performing risk assessments of the Herpetology Department archives and the library's photographic slide collection. The internship at the Stephen B. Luce Library is the first experience Ms. D'Esposito has had to create a finding aid for a collection she processed. Ms. D'Esposito processed eight of the twelve boxes that comprise the collection including boxes one through five, seven, eight, and twelve. Boxes six and nine through eleven were processed by Ms. Berilla.

Abstract

The Lillian C. Liburdi Borrone Collection contains professional and personal items collected by Lillian C. Borrone during her extensive career in the maritime industry as a prominent professional, who achieved the rank of Assistant Executive Director for the Port Authority of New York and New Jersey. The collection spans 1962-2008. The majority of the items were collected between 1984-2008 during Ms. Borrone's tenure at the Port Authority of New York and New Jersey and her subsequent retirement but also includes items collected while Ms. Borrone was a college student and during her first jobs after college. A portion of the collection is related to Ms. Borrone's appointment by President George W. Bush to the United States

Commission on Ocean Policy. Lillian C. Borrone was also appointed Recovery Coordinator for the Office of Recovery and Victim Assistance after the September 11, 2001 attacks on the World Trade Center and the Pentagon. Items within the collection include photographs, correspondence, awards, certificates, news and journal articles, scrapbooks, published works, plaques and artifacts.

Provenance

The Lillian C. Liburdi Borrone Collection was deposited at the Stephen B. Luce Library in August 2012 by Captain James McNamara, President of National Cargo Bureau, Inc. The collection was packed by Lillian C. Borrone and the contents of each box were kept in original order to the best of the processor's ability. The collection reflects the professional, personal, and academic career of Lillian C. Borrone.

Biographical Note

Lillian C. Borrone (née Lillian C. Liburdi) is currently the Chairman for the Eno Transportation Foundation's Board of Directors. Ms. Borrone retired as the Assistant Executive Director of the Port Authority of New York and New Jersey in December 2000. Ms. Borrone's career at the Port Authority started in 1984 including twelve years as Director of the Port Commerce Department. She also held the positions of Director of Management and Budget and Assistant Director of the Aviation Department. During her career at the Port Authority of New York and New Jersey Ms. Borrone traveled extensively including many trips to the different ports throughout Asia. Prior to

her tenure at the Port Authority Ms. Borrone held positions as Deputy Administrator at the U.S. Department of Transportation, and as Associate Administrator at the Urban Mass Transportation Administration. In 2001 Ms. Borrone was appointed by President George W. Bush to the United States Commission on Ocean Policy and she has been inducted into the Maritime Association Hall of Fame. Ms. Borrone earned her bachelor's degree in Political Science from American University and her master's degree in Civil Engineering and Transportation Management from Manhattan College.

Scope and Content Note

The majority of the Lillian C. Liburdi Borrone Collection contains materials collected by Ms. Borrone during her career at the Port Authority of New York and New Jersey. These materials include photographs from various career related functions, items collected during Ms. Borrone's many trips to Asia, awards and certificates earned by Ms. Borrone, correspondence to and from Ms. Borrone as well as papers and reports written by Ms. Borrone. The collection also contains various news clippings and journal articles chronicling the highlights of Ms. Borrone's career including the Fall 1991 New York Maritime Log (official magazine of the SUNY Maritime College) with an article honoring Lillian C. Liburdi on page five. A small portion of the collection contains items collected while Ms. Borrone was a college student and during her first jobs after college. Some of the items in the collection are related to Ms. Borrone's appointment to the United States Commission for Ocean Policy and includes the final report completed by the commission. Ms. Borrone also collected materials relating to the attacks on September 11, 2001

and her appointment as Recovery Coordinator for the Office of Recovery and Victim Assistance including a presentation Ms. Borrone gave at the one year anniversary of the attacks.

The Lillian C. Liburdi Borrone Collection spans 1962 through 2008 however the majority of the items were collected between 1984-2008 during Ms. Borrone's tenure at the Port Authority of New York and New Jersey and her subsequent retirement. The earliest documents contained in the collection were included as part of Ms. Borrone's college coursework comprising required readings and reflections. The latest item included in the collection is a lifetime achievement award awarded to Lillian C. Borrone for advancing women in transportation.

Arrangement

The Lillian C. Liburdi Borrone Collection is organized in twelve boxes. Items within these boxes were kept in original order to the best of the processor's ability. The system of arrangement within the boxes is primarily topical however there are some items that are arranged chronologically. Descriptions of the items were largely done at the series level with some item level descriptions as deemed appropriate based on the material. Scrapbooks have been rehoused in archival folders, with buffered tissue interfiling each page of the original scrapbook order; additional measures have been taken to enclose photographs in pH neutral envelopes for preservation purposes.

- **Box 5**: Primarily photographs and slides taken at various conferences and business trips, news and journal articles about Lillian C. Liburdi, a hardcover book titled Outstanding Young Women of America 1981, also contains an audio cassette of a keynote address given by David McCullough, box spans 1981, 1988-1993 and 1995-1996.
- **Box 6**: Documents and reports related to the United States Commission on Ocean Policy from 2004, includes the final report by the commission titled An Ocean Blueprint for the 21st Century.
- Box 7: Professional and personal memorabilia from 1972, 1993-1996, and 1999-2000.
 Materials include awards, certificates, photographs, slides, correspondence, and news clippings, also includes a small plaque with a statue of the Panama Canal.
- Box 8: Academic and professional documents spanning 1962-2008. Materials include news clippings, photographs, monographs and manuscripts.
- **Box 9**: Certificates, photographs, plaques and news articles (many framed) either earned by or about Ms. Borrone from 1978-1979, 1988-1989, 1991-1992, 1996-1997, and 2000-2004. Also includes two numbered, historical rolled prints showing "Clemanceau" with descriptions in French and Italian and a framed congressional record regarding the U.S. Commission on Ocean Policy.
- **Box 10**: Various award and recognition plaques presented to Ms. Borrone from different professional associations. Plaques are from 1978, 1980, 1990-1994, 1996, 1999-2001, and 2005 (some are undated).
- **Box 11**: Various artifacts collected by Ms. Borrone, also included are 2 photographs of Ms. Borrone. Items are from 1970-2001, 2003, 2005 and 2008 (some are undated).

Box 12: Professional and personal memorabilia regarding Ms. Borrone and/or marine transportation, includes photographs of Ms. Borrone. Also included is the Fall 1991 New York Maritime Log and materials related to the September 11, 2001 attacks on the World Trade Center. Materials are from 1976-1984, 1988, 1991-1993, 1995-2002, and 2005-2006.

Conditions of Access and Use

The Lillian C. Liburdi Borrone Collection is open to all researchers. All items from the Lillian C. Liburdi Borrone Collection must be used and viewed inside of the Stephen B. Luce Library and Archive located at SUNY Maritime College, 6 Pennyfield Avenue, Throggs Neck, NY 10465. No food, drinks, or pens are allowed near the archival materials. When handling the Lillian C. Liburdi Borrone Collection all researchers *must wear* the cotton archival gloves provided by the Stephen B. Luce Library and Archive staff. Consult the librarian or archivist for permission before taking photographs (without a flash) of the collection, or to request photocopies of the materials.

To gain access and view the Lillian C. Liburdi Borrone Collection researchers *must* make an *appointment* with the Stephen B. Luce Library and Archive.
